Hopefully I will not have to use any of these funds in the future, but as I have given Kathy signing rights on the above account, I expect her to pay any additional medical expenses, when due to age and possibly ill health I am unable to continue paying my way, as well as paying my funeral expenses. Right now, whilst enjoying good health and with my income from David's Factory Shop, as well as with Kathy's help, I am able to manage. I am really sorry that I have had to change my previous wills, when I acknowledged all the financial and moral help given to me over the years, by all my children, particularly Kathy & David as well as Gary, when I had more funds. Kathy and Gary, I do hope that you will understand.

Now that I am living in Melbourne, I appoint my daughter, Kathy Danziger, as sole Executor of my will..

I will be leaving copies of this will, together with my thoughts, feelings, and whatever, in a file, for each of my four children, Neil Kathy Melvin & Gary.





My silver bracelet is for my darling granddaughter Debra Danziger, who as a baby, teethed on it in Cape Town.

I do miss my three sons, Asher and Ava, all of whom are not able to be with me at this time.


